

# Notes on Your Registration for Internal Seminars offered by Healthy Campus Bonn

These conditions of participation refer to the lectures and workshops within the framework of the student health management of Healthy Campus Bonn.

## Conditions of Participation

The seminars are only open to students enrolled at the University of Bonn.

## Registration

In principle, registrations are only possible via eCampus. By registering/submitting in eCampus, you bindingly register for the event(s) you wish to attend. Please note that the number of participants is limited for didactic and/or location reasons. You will receive an email with information about your registration status.

## Waiting List

If all the places in the event you have requested are already taken when your registration is received, you will be placed on a waiting list in the order in which your registration is received. You will receive an e-mail informing you of your inclusion on the waiting list. If participants cancel, we will offer the place on the event to those on the waiting list. If you confirm an offered place, the registration is binding.

## Attendance/ Certificate of attendance at events

Attendance is compulsory. If you cannot attend the seminar 100 %, please inform your contact person for the seminar. A certificate of attendance for lectures and workshops will be given to participants who have attended at least 80% of the event.

## Cancellation / Non-Attendance at Events

If you are unable to attend a confirmed event, we require a written cancellation via e-mail to [healthy-campus@uni-bonn.de](mailto:healthy-campus@uni-bonn.de) in good time, at the latest by the date stated in the reminder e-mail, so that we can possibly still consider students from the waiting list.

If you cancel your registration at short notice due to illness, i.e. after the date stated in the reminder email, we will require a doctor's certificate.

Please note: An unexcused absence from the respective event or a cancellation at short notice without a medical certificate will result in you being blocked from all Healthy Campus Bonn events for the current semester. This also applies to events in the current semester for which you have already been accepted. We will inform you about your exclusion by e-mail in the given case.

## Event Cancellation

If you have received a confirmation, this is – even if not explicitly mentioned – conditional. The seminar may be cancelled due to low registration numbers, illness, or another significant reason. In this case you are not entitled to the provision of the same seminar at a later date.

## **Costs**

The costs for internal seminars are assumed by Healthy Campus Bonn.

## **Pictures taken at Events**

Pictures and videos may be recorded at all (online) events organized and administered by Human Resource Development. This includes events that Human Resource Development organizes using third parties. The images may be used for group photographs, overview photographs and campaigns.
