

# Privacy Notice in Accordance with Art. 13 GDPR and Consent

## 1. Name and address of the controller

## 2. Data processing as part of the prize draw among respondents to the student mental health survey at the University of Bonn

Students at the University of Bonn who took part in its student mental health survey can enter a prize draw to win one of 300 early-bird spots for University Sports for the summer semester 2026 lecture period or one of 100 canteen vouchers worth €10. We require some personal details in order to enter you in the prize draw. This information will be collected separately to your survey answers and will not be able to be linked to them.

### a) Scope of data processing

We will collect the following personal data from you as part of the prize draw of incentives to take part in the student mental health survey at the University of Bonn:

- (1) Last name, first name
- (2) University of Bonn email address
- (3) Student ID number

### b) Purposes of data processing

The abovementioned personal data pertaining to you will be processed in order to award the prizes (topping up the winners' Mensa Cards at the Studierendenwerk Bonn or arranging early-bird access for University Sports) and contact the winners.

### c) Legal basis for processing personal data

The legal basis for the abovementioned controller processing the abovementioned personal data pertaining to you is your consent in accordance with Art. 6, para. 1, sentence 1, letter a and, if applicable, Art. 9, para. 2, letter a GDPR.

### d) Recipients of your personal data

The data will be collected on behalf of the Center for Evaluation and Methods (ZEM) and processed by Healthy Campus Bonn. The necessary data will be shared with University Sports and the Studierendenwerk Bonn in order to conduct the prize draw and enable the prizes to be redeemed.

### e) Duration of the storage of personal data

All data will be fully erased once the prizes have been successfully given out or a year after it was collected, whichever happens first. Your data will be erased without delay once you have withdrawn your consent. If it is erased before the prize draw is carried out, before the winners' details are entered into the systems of the Studierendenwerk Bonn and University Sports or before the winners are contacted, there will be no possibility of winning any prizes.

### **3. Your rights as a data subject**

You have the following rights regarding the personal data pertaining to you:

- Right to information
- Right to rectification or erasure
- Right to restrict processing
- Right to object to processing
- Right to data portability

You can declare the withdrawal of your consent by writing to or emailing the controller named in Section 1 of this privacy notice.
